

A. Conservation Commission Report

Committee members discussed the current situation of the dunes. Article (pulled from special town meeting) discussion; the revised article will focus on the importance of natural resources to better protect the dune. The Committee discussed that in order to raise the issue at the 2024 Town Meeting, we need an education campaign so that voters have the information they need to make informed decisions.

Changes to the Wetlands Protection Act and the potential impact on Hull: protection of wetlands that had protection before Sackett v EPA. Supreme Court ruled water must be surface-connected, not hydrologic. There may be one area in Hull that is impacted.

The Hull Beach Management Committee meeting was called to order at approximately 6 p.m. on June 20, 2023, in the Hull Town Hall (second-floor meeting room).

A. Minutes.

The Committee voted unanimously to approve the minutes of May 16, 2023.

B. Guest Speaker and Fourth of July Discussion.

Chief Dunn spoke with the BMC about preparation for the July Fourth holiday. The main area of concern from the BMC was the protection of the plovers, given the fireworks and people on the beach. Chief Dunn provided an excellent summary of the department's plans to respond to illegal fireworks. As this was an educational session for the BMC, no motion was raised.

C. New Business.

(1) Vice Chair Mann asked Conservation Member Campbell for an update on the status of the illegal dune opening at Malta. No change in status.

(2) Discussion of drafting a letter to the new select board. BMC discussed that with the new select board, it could take months to get in front of the group to establish BMC priorities. Discussion around meeting cadence since the BMC does not have a charter from the select board. Vice Chair Mann read a letter from Member Pyclik highlighting the advisory role of the BMC. BMC members shared information about their knowledge of the status of the town manager interviews.

(3) Vice Chair Mann raised the idea of a Summer Form as the BMC did not hold one in 2022. The BMC thought it may be a good idea to partner with the Conservation Commission on the event to highlight the flood adaptation plan. Member Plotkin suggested the programming should include education about other climate issues, such as rising water temperatures.

Provisional minutes of May 16 meeting of Hull Beach Management Committee

The May meeting of the Hull Beach Management Committee was called to order by vice-chair Susan Mann at 1:00 hours local time. Also present were Jon Plotkin, Vice Chair, Plover member, Rob Gilman, member, Kelly Crumme, member, and Linda Lewis, member. Susan Mann, member, Irvin Nesso, member and Susan Mann, member. Chris Krahforst of Conservation was also present.

Announcements to the March meeting's minutes were suggested by member Green. Motion by member Nesso, second member Green, to approve minutes with suggested changes. Unanimously approved.

Due to the incomplete town election, matters relating to interaction with the Select Board are delayed.

Director Krahforst reports that signs are up for permitted access to the beach, and that attempts will be made to permit some seasonal or permitted activities.

There was discussion of the fact that the ring regulations apply all different times at town and state parts of the beach. The committee expressed a favorable view of changing both to April, if possible, but that would require a change to town bylaws. No action was taken.

Member Nesso reports that the new commissioner of the DCR is from Falmouth and may be amenable to Hull's needs.

There was a continuing discussion of how to manage the crowds using the beach during the summer, with no resolution of the question of how the committee should advise the Select Board in this regard.

Director Krahforst reports that he is working on revising the Beach Management Plan.

The continuing discussion about 4th of July fireworks on the beach ended with agreement to make the fire drill to the June meeting of the committee.
