Dear Citizen of Hull:

In May 2008, Town Meeting voted to petition the Legislature to establish the Town of Hull Veterans Council Assistance Fund to help support Hull veterans and dependents in need, and to promote the recognition and observance of patriotic holidays. Said legislation was approved as Chapter 503 of the Acts of 2008 and signed by the Governor on January 19, 2009. Your donation to the Hull Veterans Assistance Fund will enable the Veterans Council to assist our "Hull Veterans" and their dependents in need.

Here are some answers to questions you may have about the Town of Hull Veterans Assistance Council Fund.

- Q. How can I contribute to the Veterans Council Assistance Fund at the same time I pay my taxes?
 A. Write in the amount you wish to contribute in the box provided. Make your check payable to the Town of Hull Veterans Council Assistance Fund and send it to the Town of Hull Municipal Building, 253 Atlantic Ave. Hull, MA 02045.
- Q. Is there any recommended amount I should contribute?
 A. No, any amount over \$1.00 will be gratefully accepted. The success of the Veterans Council Assistance Fund depends on the support of large numbers of individual contributions from patriotic and civic-minded citizens such as you.
- Q. Who can apply for assistance from the Hull Veterans Assistance Fund?
 A. Only Hull Veterans or their dependents that may be in need of a form of assistance.
- Q. Is my contribution tax deductible?
 A. Your contribution may be deducted from your **FEDERAL INCOME TAXES** only.
