

## **Parking Ticket FAQs**

**1. How do I pay my parking ticket(s)?**

- a. You may pay online by going to [www.plymouthcountyparking.com](http://www.plymouthcountyparking.com)
- b. In person by certified check or cash
- c. Mail in a certified check – Attn; Parking Clerk 253 Atlantic Ave Hull, MA 02045

**2. When paying by check, who should it be made out to?**

- a. Checks can be made payable to The Town of Hull

**3. How soon after issuance must I pay a parking ticket?**

- a. Tickets must be paid within 21 calendar days from the date the ticket is issued in order to avoid additional fees

**4. I lost my ticket, who do I contact to find that information?**

- a. Please call or email the Hull Parking clerk. We will be able to look it up for you.

**5. How long does my ticket take to clear at the RMV?**

- a. Tickets will be cleared within 24 hours.
- b. If paid to the Town of Hull, we will contact The Plymouth County Parking Department and they will clear the ticket upon notification (usually within 24 hrs).
- c. If paid online, The Plymouth County Parking Dept will receive an email and they will clear it from the system.

**6. How long do I have to appeal a parking ticket?**

- a. Tickets must be appealed within 21 calendar days of the ticket issuance.

**7. How do I appeal a ticket?**

- a. Please go to the Parking Department section on the Town of Hull website and click How to appeal a parking ticket. You have two ways to appeal a ticket. In person where you will fill out the appeal form or online and submit it directly to the Hull Parking Clerk. The parking clerk will review the appeal and when a decision is made he/she will contact you by letter or email. It is important to note – once a ticket gets placed on appeal, it will not accrue any late penalties or fees.
- b. If you do not agree with the parking clerk's decision you may request a hearing and he/she will schedule a day & time for you to meet in person with the hearing officer.

**8. I appealed my ticket a while ago; I haven't heard a response yet?**

- a. The parking clerk tries to review and respond to appeals within a timely fashion (7-10 days) however, it may take longer during the spring/summer months. You may call the parking clerk to follow up or reach out via email. Also, please check your junk folder if you requested to hear back via email rather than letter.

**9. I am not satisfied with my appeal decision. What can I do?**

- a. You can appeal an appeal, MA General Law Chapter 30A, Section 14 – by contacting the superior court in Plymouth County. To reach the clerk's office please call 508-747-8400 or by email [Plymouth.clerksoffice@jud.state.ma.us](mailto:Plymouth.clerksoffice@jud.state.ma.us) – Once you speak with the clerk he/she will let you know the next steps. It should be noted that the filing fee is \$275.00
