Dave discussed the new request for a Special Town Meeting. The schedule was given and is listed below:

So far there is 1 petition but we expect more. The current petition seeks a Home rule petition to add 1 off Premise Liquor License for Distribution by the Commissioners. (Select Board).

By state law (G.L. c. 39, sec. 10

- 1. Petition received on July 17, 2023 and signatures certified July 23.
- 2. STM must be held no later than 45 days after receipt of petition (start counting on July 18, 2023).
- 3. 45 days is August 31, 2023. STM must start by August 31, 2023.

By bylaw (Sections 56-3, Service of Warrant; 53-5- Closing of Warrant; Section 103-10 Distribution by Advisory Board of Warrant)

- 4. Must give at least 14 days' notice before closing warrant for other articles by petition.
- 5. Service by posting of warrant at least 14 days prior to STM.
- 6. Advisory Board to distribute facsimile of warrant at least 7 days prior to STM
