## **Town Manager Update**

The 2023 Fiscal Budget will be presented to the Select Board in mid February.

2 new positions are being added to the town workforce, an assistant to the Town Planner, Chris Dilorio, and an assistant to the Conservation Manager, Chris Krahforst.

It's too early to know what may be coming in state aid.

No especially challenging articles are expected on the Town Warrant but the following will be addressed:

- Leases for town owned properties need to be negotiated including those under Jakes Seafood restaurant,
  Mezzo Mare restaurant, and the Boy Scout building.
- A noise bylaw is expected which is being catalyzed by complaints from the neighbors around the Paragon Boardwalk.
- A property tax exemption is being considered for Gold Star families
- The Select Board will be presenting bonding of financial solutions to wrap up our remaining pension
  Liabilities.

The next town invited meeting regarding school building consolidation will be in mid February.

Phil Lemnios promised an update on condition and aging status of DPW trucks and equipment before the Scheduled review of the departments budget.

Dave Clinton updated the expected AB meeting schedule including a joint meeting with the Select Board on Feb. 16.

He also advised that meetings will continue to be remote until the towns Covid infection rate drops below 5%.
