Will not impact the budget until 2023.

Article 22 no changes in the motion. This is new legislation compliant with Federal regulations. We are mapping stormwater system, then will begin a cleaning schedule. The cost to the town will be the cost of a cleaning regimen. All work being done now to drainage system is compliant with the new regulations.

The Board of Selectmen voted 3-2 in favor of No Action.

Selectman Domenico Sestito spoke on the article:

The CARES act stimulus provides support for taxpayers. Evictions were halted by the state providing a sense of security. We don't know what will happen next. It is very uncertain what will happen in 2021. There could be a need to come back to this next year.

Selectman John Reilly also spoke:

This article was added on the last day the warrant was open for the town. It was put on to save a space and since then the federal and state governments have made money available. John would have supported the article if it was also available to homeowners. He feels this wouldn't have been for the common good.

Article 6 Budget
The budget being recommended reduces State Aid by 8.7%, Local Receipts by 4.96%, and new growth has been lowered by \$40,000. This is a \$925,000 reduction on the revenue side. \$800,000 increase in tax levy is for the excluded debt for the roadway improvement plan. The previously presented budget increased by 3.5%, it is now increasing 2.45%. The State Aid is projected to be below fy 2013 levels.
State Aid makes up about 14% of the budget. We have less volatility in our budget since State Aid makes up a lower percentage of our revenue than other towns. This is driven by school enrollment.
Operations, Schools, and IT were all reconfigured for remote work and remote learning. There has been an uptick in domestic violence and substance abuse activity. The original \$225,000 snow and ice budget has been revised to \$85,000. Small capital improvements have been removed and school budget has been reduced. The total change of 2.45% would be less than 1% without the debt exclusion. The police removed 2 cruisers from their purchasing plan for Fy21 and the schools reduced the laptop/Ipad budget by \$30,000.
