Town Manager Update

- None

Citizen's Petition

- Purpose is to require the use of gender-neutral language in all town documents and communications
- Advisory Board recommends that the author of the Citizen's Petition consider changing the date of implementation since there is a project currently underway by the Town Clerk to consolidate search information for town bylaws; the proposed date may be difficult to meet due to the current project workload of the Town Clerk
- The current version of the Citizen's Petition will go into the warrant facsimile
- Advisory Board member voiced concerns about the amount of work required to go back and make the changes to all the Town By-Laws; would rather have the petition be worded to specify that the documents be gender-neutral moving forward in time
- Advisory Board member recommends a more general reference to be used rather than "direct the Town Counsel and Town Clerk"
- Advisory Board member recommends obtaining an estimate of the cost of implementation of the Citizen's Petition the way it is currently worded

Non-medical Marijuana Establishments

- Advisory Board tried to setup a joint meeting with the Planning Board, however, Planning Board would like to meet with the public again prior to having a formal meeting with the Advisory Board
- Advisory Board member asked question about what tax rate would be associated with marijuana sales (possibility of 3% or greater)

Committee Updates: Capital Outlay Committee, Beach Committee, others

- Capital Outlay Committee – Voted to recommend a debt exclusion question be added to Town Meeting
 - Proposed 3 options for prioritizing debt exclusion funds that would be voted on:
 - Menu of items
 - Roads and Seawalls
 - Recreational structures, playgrounds, etc.
- Vocational School Committee – Team recommending not to move forward with initiative to add the Town of Hull to South Shore Vocational Technical Collaborative
