### Hull Board of Selectmen Final Minutes June 23, 2021

The meeting of the Hull Board of Selectmen was held at 7:00 p.m. on June 23, 2021 via the GoToMeeting platform as an alternate means of public access pursuant to an Order issued by the Governor of Massachusetts dated March 12, 2020 Suspending Certain Provisions of the Open Meeting Law.

Present: Jennifer Constable, Chair; Greg Grey, Vice-Chair; Donna Pursel, Clerk; Domenico Sestito, Member; John Reilly, Member. Members absent: Domenico Sestito, Member. Also present were Town Counsel James Lampke and Town Manager, Philip Lemnios.

# Request for Board to approve lease between the Town and Hull Lifesaving Museum for Pemberton Boat House

Lemnios explained that the Pemberton Lifesaving Boat House Station was acquired from the U.S. Government in 2005. The Museumhas offered many successful educational programs for residents of Hull. He recommends finalizing a long-term (30 year) lease with minimal rent (\$1) as this will help the Museum when it applies for grants for capital improvements. The lease will be structured in such a way that the Town's control over the area will be preserved. Maintenance and rehabilitation of the building would be the responsibility of the Museum but they would be able to ask for assistance from the Town if needed.

# Chris Krahforst, Conservation Administrator and Bartley Kelly, Building Commissioner re: Request for Selectmen to Adopt Stormwater Regulations

Krahforst said there is a new program under federal law called the Municipal Separate Storm Sewer System (MS4) that requires that anything that enters into a municipal wastewater system have a permit from both the federal government and the State. At Town Meeting in 2020 Hull voted to adopt a Stormwater Bylaw, which creates a Stormwater Authority, made up of a number of Town personnel including the Town Manager, Building Commissioner, Town Planner, and a member of the Conservation Commission. This group has put together a set of regulations to implement the bylaw and they are seeking a motion from the Board of Selectmen to adopt those regulations. One of the regulations gives the Authority the power to issue "Land Disturbance Permits" which will be required for land disturbances of greater than 12,500 feet and for all new commercial developments.

Reilly asked if the Town was required to adopt these regulations and Lemnios said it was. Reilly wanted to know how the land disturbance mandate would affect the average homeowner. Lemnios said there are not many lots in Hull that are 12,500 or larger so it would not have a major impact. Krahforst said this will add time and cost to permits, but it really can't be avoided as Hull faces unique challenges due to its location and environmental vulnerabilities. Some of the activity is concurrent with building permit applications, but depending on the scope of the project, they could require major developers to provide information before applications are accepted.

Reilly asked if it would be possible to add a member of the public to the Authority. Lemnios said they would need to look at the bylaw as the work is very technical, but there would be nothing to prevent members of the public from attending meetings. Lampke said that if a permit is denied an applicant has twenty-one days to appeal the denial in court.

Constable asked what the consequences would be if the Town does not adopt these regulations. Krahforst said they need to have regulations as part of the bylaw. Lemnios said he hopes the Board would adopt the regulations as this was approved at Town Meeting over a year ago and they need to make a presentation to the regulatory agencies.

Constable said she wants to make sure that the necessary information is gotten out to the public as to what this entails. Krahforst said they will add something to the Town website with relevant information.

#### Chris Krahforst, Conservation Administrator re: FEMA Community Rating System annual update

Krahforst said that FEMA has a Community Rating System (CRS) which allows for a discount on flood insurance. Hull is now at a Class VII, which is the highest rating and reflects the good work that many people in the Town are doing. This rating gives an immediate financial benefit to the residents of the Town. Krahforst said one requirement of the CRS system is that every five years they evaluate hazards in terms of frequency and severity (Massachusetts Hazard Mitigation Plan) and they are required to report to the Select Board on an annual basis. The Plan addresses what people see as the real problems faced by the Town and the mitigation of these hazards is prioritized. Krahforst said they are looking at flooding in different areas and are making improvements at getting into areas with high water problems and alerting people to potential hazards. Reilly said they are doing a great job on managing all of the new regulations but as these issues become more significant and more and more regulations come down they need to focus on helping people navigate it all. Lemnios said he feels the Town does a great job of helping people get through these regulations.

#### Lori West, Town Clerk re: Request to make the Town website the official Open Meeting Law posting location

West said that in March of 2020 when Town Hall was closed to the public due to Covid, the Board voted for the Town website to be the official site for the posting of Open Meeting Law notices. She is now asking the Board to adopt, confirm, and ratify this decision. West said that the process for posting will not change. She said she will also post a paper notice on the bulletin board outside of her office as people do check this, but the website will be the official site. If the website goes down beyond six hours, a meeting would need to be cancelled. Lampke confirmed that the website is the official posting site and in case of any disputes or issues what is on the website will be final. That is state law.

#### Open Meeting Law Requirements under new state law (open vs. remote)

Lampke said that as of June 15<sup>th</sup> the Emergency Declaration was lifted which ended the ability to have remote meetings but on the 16<sup>th</sup> the Governor signed a law that was passed by the Legislature which allowed for remote meetings or remote participation in meetings as long as the public is given timely and effective access (i.e. by telephone, internet, audio or video conferencing, etc.) to the deliberations of the body. What this means in practical terms is that Boards have three choices: they can have only in-person meetings, remote meetings, or hybrids. It can be decided on a meeting by meeting basis but it probably works better if they choose one of the three options. Special care must be taken with the technology issues involved in hybrid meetings. These changes will be in effect until April 1, 2022.

Constable asked what the Board needs to do in light of this new law. Lampke said the only requirement is that whatever type of meeting they decide to have must be specified in the notice of the meeting. Constable asked Lemnios if they had the capacity to do hybrid meetings. Lemnios said they are currently working on the technology for this. The next meeting of the Board is in two weeks and at this point the plan is to have an in-person meeting that will be cablecast by Peter Seitz.

Grey and Reilly said they are both in favor of in-person meetings. Pursel agreed but pointed out that the remote meetings have encouraged a great deal of participation and it would be great to be able to continue that through hybrid meetings. The consensus was that the next meeting would be in-person and it was decided to continue meeting on Wednesdays at 7:30 p.m.

#### **UPDATES**

There was a discussion initiated by Grey regarding the A Street pier and the timely installation of the floats. Regarding parking in that area, Reilly said they cleared out the lot near the condo and put up some roping and barrels. It seems as if they are trying to get a handle on the situation but it is hard to get workers. Constable said the lots have been well-staffed and they have added signage.

Pursel said the numbers of people coming out of Milkshakes and Munchies and waiting to pick up orders has created some problems at the crosswalk at Park Avenue and Nantasket Avenue. Constable said perhaps Bart Kelly or the Police Chief could take a look at this.

Constable said that on June 29<sup>th</sup> at 6 pm a draft plan is being presented for the grant they received through the American Recovery Plan Act and she encouraged any local businesses to participate in this meeting. She also asked Lemnios if he could present some information on Harbor funding at the July 14<sup>th</sup> meeting including amounts, time frames and where they expect the money will be spent as she feels they need to have a discussion about setting some priorities and goals. Lemnios said the various Town departments will be meeting to plan for 4<sup>th</sup> of July weekend. DCR is coming to the meeting and they should be increasing staffing for that weekend but that there is a shortage of summer help.
