Hull Board of Selectmen Final Minutes December 8, 2021

The meeting of the Hull Board of Selectmen was held at 7:30 p.m. on Wednesday, December 8, 2021 at Hull Town Hall, 253 Atlantic Avenue, Hull, Massachusetts.

Present: Jennifer Constable, Chair; Greg Grey, Vice-Chair; Donna Pursel, Clerk; Domenico Sestito, Member; John Reilly, Member. Also present were Town Counsel James Lampke and Town Manager Philip Lemnios.

Before calling the meeting to order Constable led everyone in the Pledge of Allegiance.

APPOINTMENTS

Town Clerk, Lori West re: Request to accept 2020 Federal Census precincts and boundary lines

West said that as a result of the census that was completed in 2020, the Secretary of State's office requires that the Board accept the 2020 reprecincting of the Town and their boundaries and descriptions, which were completed after many meetings with the Secretary of State's office. West said that because Hull is so small and their numbers did not change very much from 2010 they were able to keep the same map and the precincts will remain the same. She said that former DPW Department Head Joe Stigliani and surveyor David Ray were both very helpful in reading the maps and boundaries and they are confident that the boundary descriptions match the map that they have given to the State.

Discussion of the renewal of licenses for Paragon Entertainment Ventures

Lemnios explained that after the last meeting on this license they reviewed the license conditions extensively as there are two periods involved, pre-Covid and Covid. He said that because Covid restrictions are expiring, the applicant is seeking renewal of the pre-Covid license for the entire complex that was approved by both the Selectmen and the ABCC. He explained that in 2018 and 2019 the Board approved a series of licenses for various locations on the site, each license with its own conditions in terms of hours, service of alcohol, etc. When Covid came into play in March of 2020 many places were closed completely and as they began to be allowed to reopen there were restrictions put into place on seating distances and on live music. Lemnios said the Board has asked the applicants to postpone their presentation to next week's meeting to make sure everything is clear as they know there is intense public interest in the topic. He said he will ask the Police Chief to attend the next meeting in order to address the issue of noise complaints. The next meeting will be remote but will be posted online so that people will be able to participate.

Several residents of the Horizons condominium complex who were present raised the issue of noise and the amount of building that is going on in that area. Reilly recommended that they not be afraid to register complaints as they occur so that they can be documented. Lemnios pointed out that the building of condominiums in this area was approved at Town Meeting and that it is a mixed-use area which combines commercial and residential space and the Town has to find a balance between the two. He stressed that residents should attend Town Meeting so that they have a voice in decisions that are made in the Town. One resident asked if it would be possible for them to obtain a copy of the existing licenses for this area and Constable said that they could.

Reilly noted that Gillis had served on the Board of Health for forty years and has been a great asset to the community.

Lemnios said this is an advisory that was sent to towns and municipalities due to certain things happening at Boston bars. Constable noted that this can happen anywhere but at this point it has not been an issue locally.

DISCUSSION

HRA Parking Permit Conditions

Lemnios said they felt that it would be good to have potential permit requirements formulated now so they can be given to the HRA to incorporate into the RFP if they intend to operate a parking lot next season and that they have come up with a draft outline of proposed protocols. He said there will be a maximum of 600 spots for paid parking.

He said that 500 spots would be in the first large lot closest to the hotel, 100 paying cars would be in the Phipps Street end of the HRA and that area would also accommodate any resident with a resident sticker with no charge. There would also be a maximum of 50 cars in the triangle lot that would be reserved for Hull residents exclusively from the hours of 8:00 a.m. to 5:00 p.m. These 50 spots are not counted in the 600 total.

There was an extensive discussion regarding the best way to handle the issue of the HRA parking lot and the role of the HRA in general as well as traffic patterns and congestion in the beach front area. Sestito said he feels that a drastic reduction in the number of cars in the HRA lot would have a positive effect on the quality of life for Hull residents and said that if that property is not developed within the next few years, he is not comfortable having the land continue to be used as a large parking lot. Both Pursel and Constable expressed concern that a drastic reduction would drive people to park back in the residential areas. Grey emphasized that efforts should be made to have visitors park in the front lot, which is closest to the businesses, which would be a positive thing for the Town. He feels that a reduction in HRA parking would be a good thing but should be done gradually.

There was agreement that the Board needs to hear more from the HRA as to what is happening in terms of developing this land. Lemnios said he would try to get them in for the first meeting in January to brief the Board and the community as to where they stand. He noted that even if they had a developer in hand, it would be about two years before anything happened, given all of the environmental regulations and permitting that would have to happen as well as public hearings, etc. Constable said they may need to lean on the HRA to come up with a development plan but that they should also hear from the community as to what they would like to see developed in this area.

At this point two motions were put forth.

Motion Grey To reduce the number of cars in the HRA lot from 600 cars to 500 paid

parking spots, 400 of which will be in the large lot closest to the hotel and

100 paid spots in the Phipps Street lot.

Sestito made a substitute motion:

Motion Sestito From May 2023 to October 2023 there will be no parking other than residents

in the HRA lot. For the period up until May of 2023 there will be 500 paid

parking spots.

There was no second to Sestito's motion, so a vote was taken on Grey's motion.

Reilly said he agrees with many of Sestito's points but they should have more in-depth discussions with other Town boards and should bring people to the table to talk about it. He feels they also need to examine the role of DCR, since they are reaping the benefit of the Town providing parking for their facility. He feels this issue should be placed on a future agenda. The consensus is that more discussion was needed with a variety of people. Lemnios said he would have the HRA come to a meeting in January so they can determine if they are actually going forward with development at this point.

BOARD UPDATES

Reilly said he wanted to thank those who donated trees to the Town. Four trees went to Veterans via Craig Wolfe and Paul Sordillo, one went to the gazebo at the War Memorial, and the other to the gazebo at Mariner's Park. Reilly said that Wolfe and his sister, Kim Greaves, are instrumental in pushing many projects in town for veterans in need.

Sestito congratulated the Hull Football team for reaching the Super Bowl at Gillette. Pursel said the Citizens Advisory Board of the Weir River Water System met this week and the results of their studies will be sent out at the end of the year. She said that there will be a meeting in February with joint committees formed from Selectmen of each town and the Chair of the water system. Once they have met public forums will be held. She reminded everyone that this Sunday is the Chamber of Commerce's "Home for the Holidays" from 12 pm to 4 pm.

Reilly said there has been some chatter on social media about the accuracy of the sewer and water bills. Lemnios said he would check into this but he thinks it was a result of the conversion from one system to another and that adjustments would be made once everything is complete. Pursel said that the Weir River Water System is aware that some people have had a problem and are very open to hearing from people about this.

Constable thanked the EDC, their consultant, and Chris DiIorio and said she heard there was a great turnout at the Business Improvement District presentation. She said they will follow up on this in the next few weeks. She also asked if the Board was in agreement that they would move to online meetings at least until mid-January. Everyone agreed.

Lemnios said on Monday, the 13th, he and Lampke will be attending a hearing in the Legislature on the Town's request to add five additional alcohol licenses. He said Representative Meschino indicated that the Legislature usually puts very stringent conditions on expansion of licenses to cities and towns so it is unlikely that they will get five but they may get something. If they are granted additional licenses they will likely expire after three years.

Lampke said that as the Board knows, Hull joined many municipalities throughout the country in class action litigation against the opioid manufacturers and distributors due to the terrible impact opioids have had on the country because of the way they were distributed. The Town has been notified that a provisional settlement has been reached with the three largest opioid distributors, Amerisource Bergen, Cardinal Health, and McKesson and also the opioid company Jensen, Johnson & Johnson. The process requires that they agree to the settlement by January 2, 2022. The Board's approval is needed for this. He does not anticipate a large payment to the Town but feels it was important to have as many communities as possible join together to send a message to manufacturers and distributors that the country is not pleased with the way this has been handled. He would ask the Board to authorize the Chair or the Town Manager to sign the necessary paperwork to effectuate approval of the settlement.
