April 4, 2019

The meeting of the Hull Board of Selectmen was called to order at 7:30 p.m. on Thursday, April 4, 2019, at Hull Town Hall, 253 Atlantic Ave., Hull, Massachusetts.

Present: Domenico Sestito, Chair; Jennifer Constable, Vice-Chair; Kevin Richardson, Clerk; and Greg Grey, Member. Also present were Town Counsel James Lampke and Town Manager Philip Lemnios. John Reilly, Member was absent.

APPOINTMENTS

Public Hearing: Jane Wicks, Manager, HK Too, regarding license amendments

Those who wished to speak during the public hearing were sworn in prior to the discussion. Jane Wicks, Manager, HK Too LLC., dba HK Too, 276 Nantasket Ave., asked the board to approve a change in the business's license from 120 seats to 90 seats (outdoor seating only). The indoor space will no longer be used for seating. The existing indoor bathrooms will continue to be used for customer restrooms. They are requesting no change to the entertainment license. They are not proposing a change in hours. Grey stated that he had noticed that the restaurant had been closed at times during busy days during the season. Wicks said that they cannot be open on Mondays and Tuesdays, based on their business model and working hours. Richardson noted that the license says open on Tuesday and Wednesday from 11 a.m. to 9 p.m. Lampke explained that a business is expected to be in operation during the hours on the license. Lemnios explained that the license should reflect the business's regular hours of actual operation and that the license could be amended. After discussion the board voted as follows:

Continuation of discussion regarding shade tree at 184 Nantasket Road

The board continued its discussion of a request by the owner of property at 184 Nantasket Road, made via their builder, to remove a large and old shade tree from the property. The request was to cut down the tree and plant replacement trees. The board had previously conducted a site visit to view the property and the tree.

The following town residents spoke in opposition to removing the tree, citing the value to the community of a mature shade tree of this size: Tom Burns, 1 Clifton Ave., Alan Osgood, 125 Newport Road; Lisa Campbell, 107 Atlantic Ave.; Susan Etkind, 197 N. Truro Street; Susan Thomas, 88 Clifton Rd.; Jane Wicks, 67 Whitehead Ave.; Katherine Borsody, 29 Andrew Ave.; [Resident] 100 Clifton Ave.

Selectmen Richardson noted that the board was also in receipt of numerous letters and emails opposing removal of the tree. Both Richardson and Constable noted that the board had never heard from the owner of the property. The builder had submitted a letter of request, but neither the builder nor the owner was present at the meeting.

Public Hearing: Red Parrot, Inc., dba Inspire Eat and Drink, regarding transfer of all licenses

Those who wished to speak during the public hearing were sworn in prior to the discussion. Walter Sullivan, Attorney, spoke on behalf of John Brian Houlihan, Houlihans Seaside, Inc., the new owners of The Red Parrot, Inc., dba Inspire Eat and Drink, 1 Hull Shore Drive. This was a public hearing to transfer licenses to the new owner.

Sullivan stated that Houlihan has several successful restaurants on the South Shore, including Scituate, Cohasset, Norwell, and Hingham. He said that the restaurant will have a bar, dining room, kitchen on both floors, as well as a lounge on the first floor and a deck space on the second floor. There will be two entrances and seven exits. It will seat 393. The proposed hours of operation for the food and alcohol license are 8 a.m. to 1 a.m., Monday through Saturday; and 10 a.m. to 1 a.m. on Sunday. The entertainment license will be Monday through Sunday from 10 a.m.

to 1 a.m. Houlihan stated that he is applying the keep the licenses for music and entertainment in effect	, including
for the outside patio space. They hope to be partially open by Memorial Day.

HRA UPDATE

Members of the Hull Redevelopment Authority were present at the meeting to provide the board with an update on the current status of plans for development. Present were Bartley Kelly, Chair; Spencer O'Loughlin, Vice-Chair, Dennis Zaia, Clerk; and Evan Shuman. Kelly stated that neither of the two proposals the HRA had received for the property development were suitable under the rules/laws the HRA must follow under the RFP process. It has therefore decided to file a new urban renewal plan with the state. This will allow it more flexibility in seeking development proposals. He stated that there is still interest in the property.
