NEW BUSINESS

Lemnios updated the board on an ongoing situation in which residents throughout town were experiencing brown tap water in their homes over the weekend and in the beginning of week. He stated that the town urged Aquarion Water to communicate with the residents, but they held off doing so. Aquarion finally issued a Code Red to a limited number of residents. The Code Red did not include any information on what actions residents should take, nor did they provide any information to businesses or restaurants. He stated that the company claims that the problem is due to high demand. Lemnios asked the board authorize Town Counsel James Lampke to ask the DPU to conduct an investigation into this matter, as neither Hingham nor Cohasset experienced this problem, nor did the sewer treatment plant experience any spike in flow.

He stated that the Board of Health and the selectmen were approached about whether the water was safe to use, and stated that Aquarion has to provide that guidance, as the town cannot do so for reasons of liability. He stated that the Fire Department, the Board of Health contacted Aquarion and they kept delaying any action. He stated that he would like to know what the company's flushing plan is. He asked the board to vote to authorize Town Counsel to proceed.

Rhoda Kanet said that she never got a Code Red until Tuesday morning and when she did get one, it did not give her appropriate information. She did not get an email. She called Aquarion and asked why there was no communication on Monday. She flushed her pipes and it got worse. Aquarion then said that she shouldn't have done that, but this was not communicated in the Code Red. Aquarion also told Kanet that this has never happened before in other times of high water usage.

APPOINTMENTS

Public Hearing: Paula Coffman and Rafca Cardoos, regarding To Dine For

This was a public hearing to consider the request of Paula Coffman and Rafca Cardoos, owners of To Dine For, 518 Nantasket Avenue, for a new common victualer license. Coffman and Cardoos were present at the meeting and explained to the board that they have been at 520 Nantasket Avenue for nine years and just expanded into 518 and would like to put a few seats in the new location. The Building Department and the Board of Health have the plans. The board's approval would be subject to them having all applicable inspections and approvals. Kanet said that she supports this endeavor and that they are an asset to the town.

Richardson updated the board on the plans for the 375th Anniversary, which is next May. He said that there will be a meeting next Wednesday night at 7 p.m. in the high school exhibition room for anyone who would like to contribute ideas or volunteer for committees. NEW BUSINESS

Lemnios said he has met with Jason McCann of the Community Preservation Committee, which is now collecting pre-applications. He stated that he did not want to give people the false impression that groups can make plans for town-owned land that leapfrog the capital plan. He said that the CPA is a key source of funding for the that plan. He suggested having the CPC and the Capital Outlay Committee in for a meeting with the board. Richardson suggested that the town should ask the CPA for money to address the outside of Town Hall.

Lemnios further stated that the Solid Waste Task Force is up and running, with someone from the DEP providing technical support. He said that there will be a public meeting on September 12 at Town Hall. In addition, he suggested that the board meet with the Board of Health and the Advisory Board on this matter.

Lampke said that regarding the sewer plant law suit, a settlement has been reached in principle with the insurance company, the details of which will be released to the public when all of the particulars have been agreed upon. The town will be pursuing a case against the operator and any other parties.
