CORRESPONDENCE

Cinzi Lavin, 31A Bay St-re-Re-appointment to the Historic District Commission

A letter from Lavin stated that she is resigning as a full member of the Historic District Commission and would like to be reappointed as an alternate. Sestito stated that they would accept the resignation and make new appointments in June.

NEW BUSINESS

Reilly stated that the Memorial Day concert at the Bernie King pavilion has been cancelled due to work being done on the structure. The first concert will be on July 4th.

Reilly also stated that the 375th Anniversary planning is underway. A proclamation will be made at Town Meeting. The committee is also co-funding the HYFA carnival fireworks in June. On Saturday, Aug 17, there will be a parade from Kenberma to L Street, followed by a field day at L Street field. New lighthouse pins and anniversary flags have been ordered and will be available for purchase. There will be a community meeting on May 23 at the high school cafeteria at 7 p.m. for those who wish to get involved in the anniversary planning. Anyone interested is welcome.

APPOINTMENTS

Appointment of Memorial Middle School Building Committee

This item was held until the next meeting.

Brendan Kilroe, regarding appointment to Conservation Commission

The board interviewed Kilroe for a position on the Conservation Commission. He stated that he is also interested in serving on the Economic Development Committee, the Logan Airport Committee, and the Zoning Board of Appeals. The board will be making decisions on appointments to the Conservation Commission at a future meeting. He stated that Economic Development would be his first choice. The board will be interviewing for the Economic Development Committee at its next meeting, so it also interviewed Kilroe for this position at this time.

Bill Golden, regarding Climate Change Coalition

Golden was present at the meeting to discuss the National Institute for Coastal and Harbor Infrastructure and the Climate Change Coalition. He said that the group is trying to reach a regional coalition of municipalities, and believes in a layered defense to deal with sea level rise and, separately, storm surge. He stated that sea level rise is incremental and can be dealt with in phases. He stated that storm surge is a more devastating short-term issue and an existential danger for Hull. The group is advocating regional structures for storm surge inundation protection. He presented two current options being put forth at this time involving storm surge barriers. He said he would like to see a commitment of \$25,000 from Hull to be part of the coalition.

Sestito noted that the board would take it under advisement and invited Golden to continue to discuss this matter with Town Manager Lemnios.

Town Meeting Warrant Review, Continued

The board continued its review of the 2019 Town Meeting Warrant. [See warrant.]

Sestito asked the board to revote on its support for Article 1 of the Special Town Meeting, as Grey was not present for that vote.
