Hull Board of Selectmen Final Minutes November 7, 2019

The meeting of the Hull Board of Selectmen was called to order at 7:30 p.m. on Thursday, November 7, 2019, at Hull Town Hall, 253 Atlantic Ave., Hull, Massachusetts

Present: Domenico Sestito, Chair; Jennifer Constable, Vice-Chair; Kevin Richardson, Clerk; John Reilly, Member; and Greg Grey, Member. Also present were Town Counsel James Lampke and Town Manager Philip Lemnios.

APPOINTMENTS

My Starfish LLC dba Shipwreck'd, 173 Main Street - re: Discussion on Pemberton building

Adrian Muir was present on behalf of My Starfish LLC to update the Board on the intention of My Starfish LLC to apply for a seasonal liquor license for Shipwreck'd for their peak season, which runs from approximately April through November. Since they are within 500' of a school they have already met with the School Committee and School Superintendent to advise them of their proposal and have received a unanimous approval of their proposed plan. At this point they would like to determine what further steps they might need to take to move forward.

Sestito advised Muir that if they do apply for a liquor license they would need to notify all abutters, who would have the right to speak at a public hearing. Lampke noted that they need to file an application and that there would be a public hearing on this matter; accordingly it is not appropriate for the Board to give an opinion on its viability prior to the application and hearing. Sestito expressed appreciation that My Starfish LLC is approaching this matter in a thorough and timely manner. Lampke advised Muir that the next step would be to apply for a liquor license and emphasized that all parties to the lease of the property need to be involved in the application process.

Reilly raised the issue of the high volume of traffic in the area and stated that the Board would need to stay on top of this situation in order to ensure the safety of patrons parking in this area. Constable agreed with these concerns. At this time Reilly excused himself from the remainder of the meeting.

CORRESPONDENCE

A letter of resignation from the Capital Outlay Committee dated 11/1/2019 was received from Richard Kenney, 1 Rivers Edge Road, as the Committee has not met for over a year. Lemnios will send Kenney a note thanking him for his many years of service on the Capital Outlay Committee as well as the Advisory Board.

Lemnios read correspondence dated 10/30/2019 from the Massachusetts School Building Authority inviting the Town of Hull to partner with the MSBA in conducting a Feasibility Study for the Hull Memorial Middle School. A feasibility study will be completed and submitted to the MSBA to see if they are willing to advance the project to the funding stage.

CONTINUATION OF DISCUSSION RE: BOARD OF SELECTMEN GOALS AND OBJECTIVES

Lemnios stated that since the last meeting members of the Board have submitted items that they feel deserve the attention of the Board. Lemnios has created a master list of approximately 50 items and feels that the Board should take the time to consolidate and prioritize these items.

The items submitted fall into 8 categories:

- 1. Capital Plan
- 2. Communications
- 3. Economic Development and Community Development
- 4. Housing
- 5. Open Space and Recreation
- 6. Operations
- 7. Resiliency Plan
- 8. Transportation

There was extended discussion as to how to best consolidate the items under each of these categories. Lemnios will create a "cleaned up" version and will circulate it to the Board. Members should respond in order to create the top priorities under each category.

NEW BUSINESS AND OLD BUSINESS

Lemnios reminded Board members of the Veterans Day service to be held at 11:00 a.m. on Monday, November 11th as well as the Special Town Meeting which will be held at 7:00 p.m. on Monday, November 18th. He will supply the Board with a list of the scheduled dates for December Board meetings.

Constable reported on developments with the South Shore Coalition. She feels that the Coalition is making real progress in the area of developing the South Shore region as a tourist destination. She encouraged members to attend their next meeting in Hingham on November 21, 2019.

Lemnios gave an update on ongoing Town projects, all of which seem to be going well.
