Hull Board of Selectmen Final Minutes December 5, 2019

The meeting of the Hull Board of Selectmen was called to order at 7:30 p.m. on Thursday, December 5, 2019, at Hull Town Hall, 253 Atlantic Avenue, Hull, Massachusetts.

Present: Domenico Sestito, Chair; Jennifer Constable, Vice-Chair; John Reilly, Member; Greg Grey, Member. Also present were Town Counsel James Lampke and Town Manager Philip Lemnios. Member Kevin Richardson was absent.

Manet Community Health Update

Cynthia Sierra, CEO of Manet Community Health Care and Matt Littlefield from the Board of Directors were present to give an update on the work and mission of Manet. Sierra stated that it is the mission of Manet to provide health care for all. She reported that they currently have \$20 million in revenue and that 14% of that revenue comes from the Hull location. 43% of their primary care patients reside in the 02045 zip code. The largest age group they serve is 20-64, but the medicare population has been increasing yearly. The Hull location currently has 2 internists who are supported by a team of nurse practitioners as well as behavioral health, substance abuse and mental health professionals. They are open 6 days a week and evenings. They currently work with the Senior Center and would like to explore the possibility of working with Emergency Services. They are eager to explore avenues in which they can collaborate with the Town.

Lemnios asked what Sierra sees as the biggest challenge for Manet in the next 5 years and how these challenges might affect Hull. Sierra feels that recruiting and maintaining a work force is the biggest challenge they currently face. They are working hard to remain fiscally healthy so that they can be competitive in the salary and benefits they offer. She stated that they ended last year in good financial standing. Lemnios also asked if Manet is part of a larger health care system. Sierra responded that Manet remains an independent federally qualified health care center. They do, however, have a good working relationship with area hospitals and health systems, particularly Boston Medical Center.

Constable asked if there were any particular challenges that Manet faces in the Town of Hull. Sierra responded that the biggest challenge faced by many of their patients is transportation. They are looking into resources to transport patients who need more specialized care where they need to go. There is also an issue of nutritional instability in the area and they are looking into opportunities to bring fresh produce directly into the facility. This is something that they currently do in their Quincy and Taunton locations.

The members of the Board thanked Sierra and Littlefield for providing this update and for the great work that Manet is doing in the Town of Hull. They expressed a desire to explore additional ways in which the Town can work with Manet to expand the services they offer.

Paragon Entertainment Ventures, LLC dba Paragon Boardwalk, 189-197 Nantasket Ave., Charles Boggini, Mgr. – re: Change of Hours of Operation; (A) All Alcohol; (B) Common Victualer; (C) Auto Amusement; (D) Entertainment (RENEWAL)

Charles Boggini, Manager of Paragon Boardwalk, was present to discuss the change of hours that they are proposing for the upcoming year. They are hoping to keep Paragon open year-round, but it would be extremely difficult to do so with the current hours of operation. Lemnios stated that they have worked with Paragon to come up with new hours and a spread sheet was provided outlining the hours that would be in effect with the renewal. He stated that there will be a Hearing in two weeks to address the exterior portions of the project site. Over the course of the next six months there will be construction in that area and the hearing on the 19th will be for the licensing of that area. Tonight's meeting is solely for a renewal of the existing conditions which reflect the new operational pattern.

Following the vote Sestito explained that several years ago, due to the opioid crisis that has plagued the nation, our state, and the Town of Hull, the Board had asked Lampke to explore what possible legal options the Town might have to combat the crisis. Based on Lampke's findings the Town has joined a multi-district litigation with other towns and communities throughout the state and across the country who are participating in a lawsuit against pharmaceutical companies and other corporations that are involved in the manufacture and distribution system of opioids. There is no financial commitment on the part of the Town as the legal fees involved would be taken from any restitution or compensation that the Town might receive as a result of this litigation.

The meeting was adjourned at 9:04 pm. The Board will meet next on December 19, 2019 at 7:30 pm.
