Chris Krahforst, Conservation Director, regarding Beach Management Plan

Chris Krahforst, Conservation Director, presented the town's updated Beach Management Plan. This is a plan detailing the best practices for management of the beach and the primary dune area. It includes sections on:

Civil Service Appointments

Lemnios explained that the Police Department is in the process of interviewing candidates for patrol officer, and Chief Dunn had asked him to invite board members to make arrangements to meet with him or Deputy Chief Reilly to review the list of candidates.

NEW BUSINESS

Lemnios stated that he attended a recent meeting in Hingham regarding the "road diet" project that would reduce travel lanes leading into the Hingham rotary going north. He said that Hingham is interested in pursuing a pilot program this summer and has been very responsive to the concerns of Hull and other local towns about the impact of this change. They will be having a public meeting in Hull in upcoming weeks.

Reilly noted that there has been a lot of gas line work going on and asked about road repair. Lemnios said that they will be coming back soon to do permanent patching. Reilly also suggested inviting the HRA in to discuss their twoway road project. In addition, he suggested having Police Chief Dunn come in to discuss protocols regarding school safety. Lemnios said that some or all of that discussion would have to be held in executive session.

Constable said that the MAPC Legislative Committee has voted to support the governor's opioid care act, which supports a trust fund for schools and opioid education, increasing communications among first responders, and ease of access to Narcan. She also stated that she attended a housing conference and noted that new tax changes eliminate small disaster deductions, which could impact coastal communities.

The Pemberton Planning Committee will meet on February 27 at 7 p.m. in the high school exhibition room.

Richardson reminded residents that a group called Laundry Love helps people do their laundry on the fourth Monday of every month at the laundromat, and will be there on February 26 at 4 p.m.
