REQUIREMENTS FOR PRIVATE SWIMMING POOL BUILDING DEPARTMENT

- I. PLOT PLAN SHOWING LOCATION OF POOL AND ANY OTHER BUILDINGS ON LOT, ALSO SHOWING HOW IT WILL BE FENCED.
- 2. POOL WALL MUST BE AT LEAST 6FT FROM REAR AND SIDE LOT LINES, AND CAN'T BE LOCATED IN FRONT YARD SETBACK AREA (25FT).
- 3. APPROVAL MUST BE GRANTED FROM THE BOARD OF HEALTH AND CONSERVATION COMMISSION.
- 4. ELECTRICAL PERMIT MUST BE APPLIED FOR AT THE SAME TIME AS POOL APPLICATION IS SUBMITTED.
- COMPLETE PLANS OF POOL CONSTRUCTION AND FILTERING SYSTEM MUST BE SUBMITTED.
- 6. ALL POOLS MUST HAVE A FENCE AND GATE AT LEAST 6FT HIGH SURROUNDING THE PROPERTY OR POOL AREA. ALL GATES MUST BE SELF LATCHING WITH LATCHES PLACED 6FT ABOVE UNDERLYING GROUND OR OTHERWISE MADE INACCESSIBLE FROM THE OUTSIDE SMALL CHILDREN. ALARM ON DOORS WITH ACCESS TO POOL AREA.

BOARD OF HEALTH

- I. IS IT FENCED?
- ALL BACKWASH IS CONSIDERED SEWERAGE. IT MUST BE DISPOSED OF IN PUBLIC SEWAGE SYSTEM OR A DRY WELL. DRY WELLS MUST BE 20' AWAY FROM HOUSE AND 10' AWAY FROM PROPERTY LINE.
- BOARD OF HEALTH OFFICE NEEDS A COPY OF SWIMMING POOL DESIGN AND A PLOT PLAN OF THE PROPERTY INDICATING HOUSE, POOL, DRY WELL, PROPERTY LINE AND DISTANCE.
- 4. WHAT KIND OF DISINFECTION IS USED.
- 5. COMPLETE INFORMATION SHEET SUPPLIED BY THE BOARD OF HEALTH AND PAY APPROPRIATE FEE. (\$30.00)
