6.1 Jacobs School Handbook

Ms. Christine Cappadona, Jacobs School Principal, stated that the Jacobs School Handbook has three policy updates; student records, homework, and technology. She said the dates, names, times and other routine edits that do not affect the meaning of the handbook have been made.

 - Objective: Continue the implementation of best practices to address the academic needs of students.

 - Objective: To use assessment data to inform instruction.
- Improvement Area Four: School Culture
 - Objective: Incorporation of skills and techniques associated with Social and Emotional Learning.

6.5 Hull High School Handbook

Ms. Nicole Nosek, Hull High School Assistant Principal, stated that the three policies that changed in each of the other handbooks are also included in the high school handbook; these include student records, homework and technology. The high school also had several changes to the athletic policies to align with MIAA. Dates, names and other routine edits that do not

affect the meaning of the handbook have been made.

6.6 Hull High School – School Improvement Plan

Dr. Paula Girouard McCann, Hull High School Principal, brought forward her School Improvement Plan, which includes the following objectives and strategic plan for improvement:

- Improvement Area One: School Culture
 - Objective: Continue to increase parental awareness and involvement at Hull High School
- Improvement Area Two: Student Achievement
 - Objective: improve the academic transition and social adjustment to the high school for all freshmen
- Improvement Area Three: Student Achievement
 - o Objective: Improve the students' college and career readiness
- Improvement Area Four: School Culture
 - o Objective: Develop an advocacy-based advisory program
- Improvement Area Five: Instruction
 - o Objective: Investigate the feasibility of using "blizzard bags" to prevent loss of instructional time

6.7 Technology Update

Mr. Anthony Hrivnak, Memorial School Principal, informed the Committee that the Technology Committee met several times during the course of the year. He stated that they sent out a technology use survey, discussed blizzard bags and ran a Chrome book pilot program at the high school. He said that 95% of the middle school students use their iPad every day and they would like to continue using them but only half of the high school students used theirs. Dr. Paula Girouard McCann, Hull High School Principal, stated that the high school students that participated in the Chrome book pilot program joined Dr. McCann in a luncheon focus group to discuss their findings. She said that the students all loved the Chrome books for a number of reasons. Mr. Hrivnak stated that the end result is that the Technology Committee is recommending Chrome books at Hull High School and the current iPads be recycled down to the middle school. The iPads still have two years on their three year warrantee. The Technology Committee is also recommending purchasing Chrome book carts for the elementary school. Ms. Cappadona, Jacobs Elementary School Principal stated that using the iPads and Chrome books at the elementary level will help when children will eventually have to take the MCAS test using only technology. The principals responded to questions for Committee members.
