The meeting of the Hull Select Board was called to order at 7:30 p.m. on Wednesday, September 7, 2022 at Hull Town Hall, 253 Atlantic Avenue, Hull, Massachusetts.

Proclamation: Board Recognition of National Suicide Prevention Month

Constable offered the following Proclamation to the Board for adoption:

WHEREAS, suicide is the 10rh leading cause of all deaths in the U.S. and the 2nd leading cause of death among individuals between the ages of 15 to 24;

WHEREAS, it is estimated that 5 million people in the U.S. are survivors of suicide loss;

WHEREAS, an increase in the overall suicide rate in our country was seen in 2019, representing a change in the recent pattern of stability or slight declines;

WHEREAS, suicide is a community problem and thus there must be a community response through various initiatives to reduce suicidal behaviors;

WHEREAS, the Plymouth Suicide Prevention Coalition, which is dedicated to reducing the frequency of suicide attempts and deaths through education, awareness and action, urge that we as a community:

- 1) Recognize suicide as a national, state and town public health problem and declare suicide prevention to be a Plymouth County priority;
- 2) Acknowledge that no single suicide prevention program or effort will be appropriate for all populations or communities;
- 3) Encourage local initiatives based on the goals contained in the *National Strategy for Suicide Prevention* that will
 - a) Develop and implement strategies to reduce the stigma associated with being a consumer of mental health, substance abuse, and suicide prevention services.
 - b) Develop and implement community-based suicide prevention programs and suicide bereavement support services.
 - c) Implement training for the recognition of at-risk behavior and for the delivery of the effective treatment.
 - d) Increase access to, and community linkages with, mental health and substance abuse in the entertainment and news media.

WHEREAS, a great many suicides are preventable; THEREFORE, IT BE RESOLVED that, we, the Hull Select Board do hereby designate September 10th, 2022, which overlaps World Suicide Prevention Day on September 10th, as "National Suicide Prevention Month" in the Town of Hull, Massachusetts.

Constable repeated that Letters of Interest are being accepted for vacancies on Boards and Committees and said the Select Board will revisit these in the next meeting or two for interviews on new appointments. Pat Finn noted Neil Kane's departure from the Zoning Board of Appeals and suggested that he be recognized in some way for his many years of service to the Town. The Board was in agreement with this.

Susan Mann from the Beach Management Committee said that they are looking for direction and feedback on their activities and mission and would like to have a representative on the Select Board on the Committee. Constable said that given the number of subcommittees it is not realistic for there to be a Select Board representative on each of them but that if there is a meeting at which a committee feels a particularly important issue is being raised, they should notify the Select Board and ask that a representative be present. She also suggested that they might consider submitting a quarterly report to the Select Board for review and said that if the Beach Management Committee is truly unsure of what their charge is they should request to have this placed on a future Agenda. Lemnios noted that there has been a great deal of work done in the beach area in recent years such as the closure of some unpermitted openings in the beach, the insulation of beach mats, and the situation with the plovers, but said the Board is not in a position to address all of the issues raised by the Committee. He said that he does feel it would be valuable to have a discussion of the role of the Committee going forward.

UPDATES

Lemnios said the Atlantic Avenue project is moving forward and that utility work and underground drainage should be complete in the near future. He said there are two major upgrades happening at the Sewer Treatment Plant, the insulation of the HVAC system as well as improvements to Pump Station #9, and that both of these are on target. He noted that there will be an announcement for grant awards for seawalls tomorrow and they hope the Fitzpatrick Way project will be favorably announced. This is a \$4 million project, but a state grant would cover about \$3 million of it. He also said that Congressman Lynch has secured an earmark on the federal level for an additional \$5.8million that is working its way through the Appropriations Committee.

Pursel asked Lemnios about the camera on a light pole on Nantasket Avenue near Edgewater and Lemnios said it was a traffic counter for the two-way road street project as they are seeking state funding for this project and need to submit traffic counts as part of the design element. Constable asked about paving. Lemnios said TL Edwards has finished up the bulk of their roads but are saying they will not have enough band width to complete the Kenberma section until next spring.

Constable said they received a letter from the MBTA Advisory Board. She said every community has an ex-officio seat on the Advisory Board and in recent years she has been the Town's designee and would like the Board's vote to continue in this position.
