Hull Select Board Final Minutes December 14, 2022

The meeting of the Hull Select Board was held at 7:30 p.m. on Wednesday, December 14, 2022 at Hull Town Hall, 253 Atlantic Avenue, Hull, Massachusetts.

Present: Jennifer Constable, Chair; Donna Pursel, Vice-Chair; Greg Grey, Member; Domenico Sestito, Member. Member absent: Irwin Nesoff, Clerk. Also present were Town Counsel James Lampke and Town Manager Philip Lemnios.

Before calling the meeting to order Constable led everyone in the Pledge of Allegiance. She also asked for a moment of silence for Sheila Russell, a long-time Hull summer and then year-round resident, former Mayor of the City of Cambridge, and mother of numerous Hull residents, who died on December 12th.

UPDATES

Lemnios said that a number of Town departments had met this morning and reviewed their preparedness for winter, which is something they do every year. He said this year there is a challenge in that they have a minimum of snow plow contractors, which is an issue statewide. He said that this may mean if there is a large and intense snow event it might take longer for the roadways to be completely cleared. He also said they are working through the budget process and the budget will be presented to the Board during the second week in February.

Lemnios then announced that he will be retiring on June 30, 2023. He said he feels this is a good time for him to retire as he has been able to put the Town on good financial footing and there is a good team in place in the Town at this point. He suggested that there be an Agenda item for the next meeting to talk about the process for hiring his replacement and urged the Board to consider what issues they would most like a new Town Manager to address. He noted that he is putting an Assistant Town Manager position into this year's budget. Each of the Board members thanked Lemnios for his many years of service to the Town

Sestito congratulated the Hull Football team that won the Super Bowl for the first time in 25 years, and said there will be a parade in their honor on Sunday at 11:00 a.m. He said the game was very exciting and extremely well attended by Hull residents.

Constable asked if there are still flu and booster shots available. Lemnios said they should check on the Board of Health website. Pursel asked about holiday hours at Town Hall. Lemnios said they will be closed on December 26th and January 2nd, but other than that will have regular business hours.

On a motion by Sestito, seconded by Grey, the Board voted unanimously to adjourn.
