Hull Select Board Final Minutes June 1, 2022

The meeting of the Hull Select Board was called to order at 7:30 p.m. on Wednesday, June 1, 2022 at Hull Town Hall, 253 Atlantic Avenue, Hull, Massachusetts.

Present: Jennifer Constable, Chair; Donna Pursel, Vice-Chair; Irwin Nesoff, Clerk; Greg Grey, Member; Domenico Sestito, Member. Also present were Town Counsel James Lampke and Town Manager Philip Lemnios.

Before calling the meeting to order Constable led everyone in the Pledge of Allegiance.

APPOINTMENTS

Russell Tierney, Managing Director/Superintendent re: Update on Weir River Water System

Russell Tierney, Managing Director of the Weir River Water System, was present to give the Board an update on progress to date. Tierney said the system is operating within budget, achieving its projected goals, making improvements, and complying with the Lead and Copper Rule as outlined by the EPA and MassDEP as well as closely monitoring PFAS (Polyfluoroalkyl) levels in the water. He noted that over the first two years they have installed 5800 linear feet of new water mains in Hull and have made \$1.9 million in capital improvements in the Town and upgraded the Water Treatment Plant (WTP) at a cost of about \$1.5 million. They have completed extensive inspections of fire hydrants and gate valves, have replaced over 950 aging meters, received over 9400 dig safe requests, and responded to thousands of work orders and customer service calls.

Tierney said that in order to avoid confusion after the transition from Aquarion to the Weir River Water System and the acquisition of the operator, Suez, by Veolia, they decided not to make major changes. He said that on-site staff and management, off-site support, account numbers, and billing will not change. If a customer was registered with Suez they will be registered with Veolia. He said that they are looking at the governing structure of the system and where it should head and are working closely with all Town departments to improve overall communications and planning.

In terms of the future, Tierney said they will continue to invest capital funds to improve the system, including needed repairs to the WTP. He noted that they will work to reduce the Unaccounted for Water (UAW) from 20% to under 10%, which will in turn reduce operation and maintenance costs, will complete energy efficiency audits, complete a bi-annual flushing program, improve hydraulics, and review and study the need for an additional water tank. He said that they will review Hull's Master Plan and will prioritize the work that needs to be done in the Town. Pursel asked about possible rate increases. Tierney said that there will be no rate increase next year but the condition of the existing infrastructure will determine whether increases will be needed over the next three to four years. Lemnios and members of the Board thanked Tierney for his effective management of the system and noted that he has worked well with all of the Town departments.

Tom Hardey, Founder/President, Hull PorchFest re: Hull PorchFest 2022 Presentation

Hardey said that this year's PorchFest will be very much like last year's with a similar number of bands and porches and the same footprint. The event will be held on Saturday, September 17th from 1:00 p.m. to 6:00 p.m. and he estimates that about 1500 people will attend. He said that the goal is to cultivate civic pride and community in Hull

and it is their plan, once again, to make a contribution to the Council on Aging from the proceeds. He said they will be holding the annual fundraiser at the Parrot, and will handle publicity as they have in the past. He confirmed that he will follow up with any relevant Town departments and does not expect any change in municipal services. He said they will provide portable toilets, will be responsible for all clean up, and will provide a one-day liability policy.

Constable said she is glad to see this event back and suggested that Hardey partner with Town restaurants about food. Hardey said he has approached a number of establishments and at this point it doesn't seem to work, but hopes that as the event grows this will become possible. He said there is no rain date because it is too difficult to coordinate.
