Hull Select Board Final Minutes May 10, 2023

The meeting of the Hull Select Board was held at 7:30 p.m. on May 10, 2023 at Hull Town Hall, 253 Atlantic Avenue, Hull, Massachusetts.

Present: Donna Pursel, Chair; Greg Grey, Vice-Chair; Irwin Nesoff, Clerk; Domenico Sestito, Member. Also present were Town Counsel James Lampke and Town Manager Philip Lemnios.

Before calling the meeting to order Pursel led everyone in the Pledge of Allegiance.

Robert W. Kelly (Applicant) re: Parking Permit Request to park 500 cars to be parked at the HRA lots.

Henry Dunn spoke on behalf of the application. He said that, if possible, they would like to have cars park in the Phipps Street lot first and once that lot is full start parking in the large lot closest to the hotel, as it is more difficult to reach the beach from the large lot. He also questioned the increase in the cost of the permit, and why there is no increase in fees for DCR. He pointed out that the HRA pays the cost of police details at their parking lots.

Lemnios explained that under state law DCR has exemptions from any municipal fees. He said that the Town has raised the fees due to increased costs in their operations and noted that there are costs involved in having these lots in Hull that are not covered by the police details cost. Grey pointed out that everyone who operates a parking lot in the Town will have to pay an increased fee.

Pursel recapped that there would be a total of 500 paid parking spots with a maximum of 300 spots in the large lot on Hull Shore Drive Extension and 200 spots in the Phipps Street lot, with hours of operation from 8:00 a.m. to 5:00 p.m. Hull residents with a resident permit will be able to park in the Phipps Street lot and there will also be 50 spaces available for Hull residents with stickers in the triangle-shaped lot accessed by Water Street. The Phipps Street lot will be filled first and after that cars will be directed to the large lot closest to the hotel.

be parked at the HRA lots with the provision that 200 paid vehicles be parked in the Phipps lot first and then up to 300 paid cars in the Hull Shore Drive

DISCUSSION

Review of Select Board's Rules and Regulations

Pursel said this item was added to the Agenda because there has been a great deal of discussion regarding opening Select Board meetings up for public comment. She noted that they will not be finalizing a policy on this as it is possible that there will be three new members of the Board.

Lemnios noted that there was a recent Massachusetts Supreme Judicial Court decision that has limited the ability of the Chair of a Select Board to curtail comments by the public and that for this reason many communities have moved away from a "general public speak" policy at their Select Board meetings as allowing public comments can, in rare cases, open a Town up to some legal liability. Lampke said that if specific items are going to be opened up to public comment that should be noted on the Agenda for the meeting. He said that the court decision allows speech within constitutional guidelines but that more guidance is needed on the issue. He said that he has a meeting coming up with the Executive Board of the State Bar of the Municipal Attorneys Association and he will try to get further clarification on how public comments should be handled.

It was the feeling of the Board that public input is important but that going forward Board members should have clear guidance on how public comments can be regulated. Lampke said that the Board's current rules and regulations will need to be carefully reviewed and updated so that they are in line with current Massachusetts law.

UPDATES

Nesoff said that Hull's No Place for Hate Committee had hosted a very successful event on April 19th that was attended by about eighty people including representatives from the Police Department and Wellspring. He said the event encouraged frank conversations in small groups, and Pursel, who had also attended, said she was extremely impressed by the feedback in her group.

Sestito reminded everyone that the Town election is on Monday. He said he is grateful that he has been able to serve on the Select Board for the past fifteen years and thanked everyone for the honor of serving with them. The Board thanked Sestito for his many years of service.

EXECUTIVE SESSION
