Hull Select Board Final Minutes June 14, 2023

The meeting of the Hull Select Board was held at 7:30 p.m. on June 14, 2023 at Hull Town Hall, 253 Atlantic Avenue, Hull, Massachusetts.

Present: Greg Grey, Chair; Irwin Nesoff, Vice-Chair; Jason McCann, Clerk; Brian McCarthy, Member; Jerry Taverna, Member. Also present were Town Counsel James Lampke and Town Manager Philip Lemnios.

Before calling the meeting to order Grey led everyone in the Pledge of Allegiance.

Public Hearing: PF Hospitality Inc., dba the Sandbar, 297 Nantasket Avenue, Lillian Parker, Mgr. re: Amendments to (Change of Hours) Alcohol, Common Victualer, and Entertainment Licenses.

Parker said that they would like to change the opening hours of the Sandbar on the Alcohol, Common Victualer and Entertainment Licenses, but that everything else would remain the same. She said that for the period from January 1st through May 26th and from October 2nd through December 31st they would like to change the opening hours on Friday, Saturday, and Sunday from 12:00 p.m. to 11:00 a.m. For the period from May 27th through October 1st they would like to change the opening hours from 12:00 p.m. to 11:00 a.m. Monday through Sunday. The closing hours will remain the same.

Select Board Reorganization

Grey said that he would like to make a Motion to nominate himself as Chair of the Select Board. McCann then asked him to speak about his feelings on the issue of public comments at Select Board meetings. There was an extended discussion about developing a policy on this issue, which has become problematic due to a Decision by the Supreme Judicial Court in Massachusetts that limits the extent to which a Board can control public input once it is allowed without opening itself up to potential legal liability. It was the consensus of the Board that this is an important topic that will require extensive discussion so that a policy can be developed that will allow for public input while still allowing the Board to accomplish its work in an effective manner. Lampke said he is exploring this issue and is working on a policy to address the Board's concerns. Nesoff said that the Mass. Municipal Association has developed a very helpful webinar on this topic which the Board should listen to. It was decided that this discussion should be placed on the Agenda for a meeting in the near future.

Nesoff made a Motion to nominate himself as Chair of the Select Board, which was seconded by McCann. Both McCarthy and Taverna said they would be comfortable with Nesoff as Chair, but feel that Grey has greater seniority and should be in line for the position. Nesoff then made an amended motion.

Lemnios briefly outlined the responsibilities and meeting requirements of the three Boards/Committees. He said that ideally the Select Board representatives should be in place as soon as possible. McCarthy and Taverna both said they would be interested in the Weir River Water Advisory Board, and McCann said he would be interested in the Economic Development Committee. Taverna said he would also be willing to serve on the Plymouth County Advisory Board.

UPDATES

Lampke stated that there had been some comments from the public indicating that either current or new members of the Select Board might have relationships with Town Manager candidate, Jennifer Constable, that might make it difficult for them to be impartial in the interview and selection process. Lampke said that the law allows municipal employees to avoid the appearance of a potential conflict of interest by making a public disclosure of their relationship with the person in question. Out of an abundance of caution Select Board members Grey, Nesoff, McCann, and McCarthy have filed disclosure forms from the State Ethics Commission with the Town Clerk. Each

read their disclosure letter into the record and said they will make the disclosures again before the scheduled interviews the following night.

Taverna said he had spoken with Lampke and a lawyer on the State Ethics Commission over the past few days because his wife is the Director of Public Health and would be under the authority of the Town Manager. He said it was the ruling of the Commission that it would not be ethical for him to vote for Town Manager so he will be sitting with the public and will not be acting as a member of the Select Board during the interviews. He does not foresee that this will be an issue in other situations and Lampke agreed.

McCann asked if public comments would be allowed during the interview process. Nesoff said that the Town's consultant had helped them develop a very good set of interview questions that should cover most questions that the public would have. It was the feeling of the Board that only Select Board members should be allowed to ask questions or make comments during the interviews. McCann emphasized that the process should be made clear to the public prior to the start of the interviews.

Grey and Nesoff welcomed and congratulated the new Board members. Each of the new members thanked the public for their votes and said they were excited to serve on the Select Board.
