1 EXECUTIVE SUMMARY

This Monthly Operating Report provides a summary of the pertinent information and activities that occurred at Hull WPCF during the month of April 2023.

- No lost-time incidents for the month of April.
- Continuing Covid-19 awareness- adhering to W&C, Town of Hull, and CDC guidelines and sharing any protocol updates.
- There were 152 effluent samples taken in April.
- There were no after-hours alarm calls that required a response by W&C staff.
- The Asset Management Accounts summaries for contract year #8 is attached- the latest revision date is 4/1/2023.
- There were no calls from residents for E-One grinder pump issues.
- W&C's O&M continued its efforts to support the various ongoing engineering projects and upgrades at the plant- see the projects section.
- The weekly BioBot Covid-19 wastewater sampling & monitoring program continued with W&C staff assisting Brian Kiley of the HSD when needed.



^{*} On-Going -the existing influent flow meters are strap-on doppler flow meters, and the existing pipe condition prevents getting a strong signal. An area velocity meter in the aeration tank inlet channel is used as well as the headworks influent Parshall Flume meter to monitor influent flows. All reported loadings are based on the effluent flow meter [new mag meter April 2021]. All meters are tied into the Scada system so that influent flows can be monitored.



AVERAGE EFFLUENT MONTHLY FLOWS - 2+ YEAR COMPARISON

The monthly average flow for April was 1.20 MGD, a bit less than the 2.07 MGD seen in March. The total precipitation for April was 3.90 inches, much less than March's' 6.77 inches, with no impact on the plant's process conditions. The graph below shows the 2-plus year summary of the monthly average flows.



TWO MONTH SUMMARY OF RAINFALL AND THE INFLUENCE ON EFFLUENT FLOWS




This graph shows the days where precipitation occurred [rainfall] [Blue Peaks].






Monthly Process Summary graphs from power BI: February-March-April 2023.

> EFFLUENT COMPLIANCE POWER BI GRAPHS




The quality of the effluent was satisfactory- and turbidity (NTU) levels were normal.

Sewage Gallons Treated vs Sludge Disposed





The Bioxide system was on, but the feed rates were minimal, as normal seasonal temperatures were cooler. Monthly graphs are attached below, and the daily average Bioxide use for March was about 30 gallons per day.


- The "In-Pipe" bacteria containers in the collection system manholes were changed out on April 2nd and 21st.
- <u>Slight changes</u> Hydrogen sulfide (H2S) monitoring units were recording and trending on the odor scrubber. [inlet and outlet]. Increased scrubber fan speed slightly. See graph below:







XYZ - Nantasket Ave [closest to plant]




The odor data logging unit at XYZ monitoring the overall H2S levels close to the plant. From the graph, the daily pattern of H2S levels see a rise in the mid-afternoon until late evening/early AM.

Pump station #3 - H2S is monitored at the end of the force main in the manhole at Nantasket Ave & Water Street. Bioxide is added to allow excess nitrate in the sewage system to treat the additional H2S added from other parts the system – such as PS #4, contributions from lines feeding the interceptor - PS #5, PS #6, PS #9, Spinnaker Island, etc., all the way to the wastewater plant. H2S levels through March were minimal with generally mild temps for wintertime, and adjustments for substantially less Bioxide feed were made. The average daily use of Bioxide in the collection system through April was 45 gallons per day.

6 SAFETY



It is Woodard & Curran's policy to maintain a safe and healthy working environment for all employees and to comply with all applicable occupational health & safety regulations.

- No lost time incidents were reported for April.
- Monthly PM's emergency eyewash and shower inspections, fire extinguishers, and emergency lighting inspections completed.
- Monthly calibrations were performed on all MX4 & Max XT11 gas meters.
- On-going Covid-19 Pandemic awareness with daily review and as needed and keeping in contact with all onsite contractors regarding Hull and W&C covid-19 protocols.
- W&C's Pure Safety topic for April was back safety & injury prevention.
- The monthly W&C SPARKS safety meeting was held on April 26, including a review of W&C's monthly "Lessons Learned!"
- W&C's monthly safety inspection checklist for the plant was completed.
- In April the site-wide chemical inventory list was updated. This is one of several tasks assigned annually by W&C's Safety Management group as part of Operations & Maintenance.

7 STAFF DEVELOPMENT

Training is an important part of any operation to ensure employee health and safety is assured, quality standards are supported, staff skills are improved, career opportunities become available, and higher productivity is achieved.

Listed is a general outline of training that the staff received over the course of the month:

- All staff completed W&C's monthly Pure Safety training and the staff's monthly safety meeting was held on April 26. Topics discussed were forklift operation, sitework trenching, and guarding floor & wall openings on the jobsite. Staff also reviewed the "near-miss" incidents occurring at all W&C projects during the month of March in "Lessons Learned!"
- Regular, usually daily, operational updates and process control discussions, pump station operations, Dig Safes, and the HVAC construction project work scope ongoing at the plant. Daily safety briefings and Covid-19 protocol updates if necessary.

Staffing related items:

- Plant continued to have weekend coverage supplemented with part-time staffers Roger Boltrushek and Ryan Holman, in addition to Mike S, Joe B, Luis B, Eric S, and Joel T.
- O&M Specialists Paul Horigan and Jody St George continue to assist as needed with plant O&M projects.
- Sadly, mechanic David Wilson has left W&C for another position that is better suited for him and his family.
- On March 5 &12 Eric Sutton & Luis Bello each took some wastewater license renewal required TCH classes online through NEIPCC in order to maintain their licenses. The NEIPCC 2-year license renewal is due by 12/31/2023 and is for good for the next two years.

All pump stations except for Pump Station 3 and Station D have an aerator/mixer in the wet wells.

B. COLLECTION SYSTEM MAINTENANCE

Collection system work is being documented and tracked in Utility Cloud [UC] and a summarized report for September has been included as an attachment with the Monthly Operating Report.

Woodard & Curran assisted/conducted camera work and sewer system support in the Hull collection system at the following areas during the month of September. Ongoing backup and blockage call outs requiring an increase in labor and time to support. Below summarizes W&C's efforts at the various call out locations.

There were no calls for E-One Grinder pump service—see UC summary.

There were 2 sewer backup calls from residents, one April 14 at 27 Prospect Street, which required the homeowner to call in a plumber. On April 10 the other sewer back up call came in from 173 Spring Street, a troublesome area of the collection system. W&C staff opened the nearby manhole and discovered a large pile of flushable cleaning wipes and other debris blocking the flow. The manhole was cleaned out and a normal flow resumed. Some 540 feet of the sewer line was jetted clean by Rosano-Davis. Thereafter W&C staff viewed the line via TV camera and discovered a large blockage of grease and rags contributing to the flow problem- it was removed.

- Pump station back-up power emergency generator testing- consisting of weekly no load running and a monthly loaded running.
- All Pump station wet wells were inspected in April- these monthly station inspections are completed and combined with the monthly station PM's.
- Upload new or updated tie-cards to the UC as required.
- Dig-Safe mark outs are completed throughout the Town of Hull as needed to assist and facilitate scheduled and emergency gas repairs, broken water mains, roadway paving projects, and other residential and town projects. All are listed in the UC summary.







9 PROJECT MANAGEMENT & ADMINISTRATION



A. ON-GOING PROJECTS AND SUPPORT ITEMS

April updates:

- Phase 1 construction work in the operations building is nearly complete with just some minor punch list tasks being addressed. Phase 2 lead contractor Barletta Engineering of Canton, MA has been onsite periodically and is gearing up for working in May.
- Plant Manager Mike S. and Assistant Plant Manager Joe B. continue to meet weekly with John S. and Brian K. to discuss the Hull Sewer Department operations, any treatment plant issues, the collection system maintenance, and any upcoming projects.






