1 EXECUTIVE SUMMARY

This Monthly Operating Report provides a summary of the pertinent information and activities that occurred at Hull WPCF during the month of August 2023.

- No lost-time incidents for the month of August.
- There were 159 effluent samples taken in August.
- There was one after-hours alarm call that required a response by W&C staff.
- The Asset Management Accounts summaries for contract year #9 is attached- the latest revision date is 8/23/2023.
- There were four calls from residents for E-One grinder pump issues, and two calls from residents reporting sewer back-ups.
- Third quarter's permit required Whole Effluent Toxicity (WET) testing was completed by RI Analytical Labs and the results submitted to the EPA.
- W&C's O&M continued its efforts to support the various ongoing engineering projects and upgrades at the plant- see the projects section.
- The weekly BioBot Covid-19 wastewater sampling & monitoring program continues to be done by W&C staff.




^{*} On-Going -the existing influent flow meters are strap-on doppler flow meters, and the existing pipe condition prevents getting a strong signal. An area velocity meter in the aeration tank inlet channel is used as well as the headworks influent Parshall Flume meter to monitor influent flows. All reported loadings are based on the effluent flow meter [new mag meter April 2021]. All meters are tied into the Scada system so that influent flows can be monitored.

AVERAGE EFFLUENT MONTHLY FLOWS - 2+ YEAR COMPARISON

The monthly average effluent flow for August was 1.68 MGD, a bit less than July's 1.89 MGD. The total precipitation for August was 6.04 inches, less than July's 11.02 inches, yet still a very good amount, but with no impact on the plant's process and conditions. The graph below shows the 2-plus year summary of the monthly average flows.



TWO MONTH SUMMARY OF RAINFALL AND THE INFLUENCE ON EFFLUENT FLOWS




This graph shows the days where precipitation occurred [rainfall] [Blue Peaks].




Monthly Process Summary graphs from power BI: June-July-Aug 2023.

> EFFLUENT COMPLIANCE POWER BI GRAPHS




The quality of the effluent was satisfactory, and the turbidity (NTU) levels were normal.

Sewage Gallons Treated vs Sludge Disposed



The Bioxide system was on, the feed rates were increased as the warmer summer temperatures set in. Monthly graphs are attached below, and the daily average Bioxide use for August was about 78 gallons per day.

- The "In-Pipe" bacteria containers in the collection system manholes were changed out on August 9th and 23rd.
- Slight changes Hydrogen sulfide (H2S) monitoring units were recording and trending on the odor scrubber. [inlet and outlet]. Increased scrubber fan speed slightly. See graph below:

XYZ - Nantasket Ave [closest to plant]




Nantasket Ave/Water Street [at end of PS 3 force main and PS 4 discharge]

Pump station #3 - H2S is monitored at the end of the force main in the manhole at Nantasket Ave & Water Street. Bioxide is added to allow excess nitrate in the sewage system to treat the additional H2S added from other parts the system – such as PS #4, contributions from lines feeding the interceptor - PS #5, PS #6, PS #9, Spinnaker Island, etc., all the way to the wastewater plant. H2S levels through July were normal, with some summer heat, and adjustments for more Bioxide feed were made. The average daily use of Bioxide in the collection system through August was 78 gallons per day.





6 SAFETY



It is Woodard & Curran's policy to maintain a safe and healthy working environment for all employees and to comply with all applicable occupational health & safety regulations.

- There were no lost time incidents reported for the project in August.
- Monthly PM's emergency eyewash and shower inspections, all plant fire extinguishers, and emergency lighting inspections.
- Monthly calibrations were performed on all MX4 & Max XT11 gas meters in use.
- The monthly W&C "SPARKS" safety meeting was held on August 30. Meeting included a review of W&C's monthly O&M "Lessons Learned!"- reviewing all safety related incidents occurring at all other W&C projects in July.
- W&C's monthly safety inspection checklist for the plant was completed.
- On August 15 new Hull staffers Clyde Lewis and Ben Porcher went to the Canton office for W&C's required CPR/ 1st AID/ AED training.
- With the recently added new W&C hires here at Hull, all staff reviewed the Hull Project's "Site Specific Safety Plan," which is updated annually, and the W&C "Corporate Health & Safety Policy & Procedures Manual."





7 STAFF DEVELOPMENT

Training is an important part of any operation to ensure employee health and safety is assured, quality standards are supported, staff skills are improved, career opportunities become available, and higher productivity is achieved.

Listed is a general outline of training that the staff received over the course of the month:

- All staff completed W&C's monthly Pure Safety training module and our monthly safety meeting was held on August 30- topics discussed were heat, heat stress, proper hydration, and attire for summer working. Staff also reviewed the "near-miss" incidents occurring at all W&C projects during the previous month of July in "Lessons Learned!"
- Regular, usually daily, safety briefings, operational updates & process control discussions, pump station operations, Dig Safes, and the Phase 2 construction project work scope ongoing.

Staffing related items:

- Plant continued to have weekend coverage supplemented with part-time staffers Roger Boltrushek and Ryan Holman, and the full-time W&C staff.
- O&M Specialists Paul Horigan and Jody St George continue to assist as needed with plant O&M projects.
- On August 15 W&C Hull staffers Clyde Lewis and Ben Porcher went to the Canton office for W&C's required CPR/ 1st AID/ AED training.

All pump stations except for Pump Station 3 and Station D have an aerator/mixer in the wet wells.

B. COLLECTION SYSTEM MAINTENANCE

Collection system work is being documented and tracked in Utility Cloud [UC] and a summarized report for September has been included as an attachment with the Monthly Operating Report. Woodard & Curran assisted/conducted camera work and sewer system support in the Hull collection system at the following areas during the month of September. Ongoing backup and blockage call outs requiring an increase in labor and time to support. Below summarizes W&C's efforts at the various call out locations.

- All pump stations' back-up power emergency generator testing- which consists of a weekly "no load" emergency generator running and a monthly "loaded" running.
- All Pump station wet wells were inspected in August- the monthly station inspections are completed and combined with the monthly station PM's.
- Uploading new or updated tie-cards to the UC as required.
- Dig-Safe mark outs are completed throughout the Town of Hull as needed to assist and facilitate scheduled and emergency gas repairs, broken water mains, roadway paving projects, and other residential and town projects. All are listed in the UC summary.
- On Aug 4, a call came in about a broken pipe at 110 Atlantic Avenue. Upon investigating W&C noted a broken cleanout cap, likely occurring when paving contractor P.A. Landers was re-doing the sidewalk after paving the road. The repairs were made, a dye test was done, and sewage flow was normal.
- A back up was reported on Aug 16th at 26 Orleans Road- the E-One grinder pump was found to be functioning properly and the issue within the house- the homeowner was advised to call a plumber.
- Another back up call on Aug 22 from the tenant just behind the former Nantasket Flats restaurant, which had been closed since January 1. A realtor had shown the property on Sunday Aug 20, and apparently a toilet had been flushed and the valve remained open, and the toilet supply water stayed running. Water finally emanated out of the grease trap, which is between the two buildings, causing the neighbor to call the Hull Fire Department. The property owner eventually came onsite, the toilet's water source valve was shut closed, and the emanating water stopped.
- There was a power failure at PS #9 on Monday 8/21 at 4:30 pm- however, only the pump station was without power in the area. The contracted emergency generator service provider SSG was unavailable until after 9pm, so W&C agreed for them to come the next day, as the generator was running fine, but W&C staff suspected a possible transfer switch issue. Tuesday morning W&C staff noticed a broken circuit up on the utility pole for the station- HMLP was called, and utility power was restored by 9am.
- The motor and pump assembly for pump #1 at Pum Station #4 was found to be seized during daily inspection. Seacoast Supply came on Thursday 24th to remove the pump and motor and install spares that are in storage back at the plant. Both compromised motor and pump units went right back to the Seacoast machine shop for assessment and rebuilding.
- E-One grinder pumps calls came in from residents at 5 Pond Street, 26 Orleans Road, 5 Nantasket Avenue, and 49 Wyola Avenue.

9 PROJECT MANAGEMENT & ADMINISTRATION



A. ON-GOING PROJECTS AND SUPPORT ITEMS

August updates:

- Phase 2 lead contractor Barletta Heavy has been onsite regularly along with subcontractor Annese Electrical.
- National Electrical Testing was onsite to test all the emergency generators' transfer switches.
 The 2 units at the plant were done on the 14th along with the unit at PS#9, and all the other pump stations' generators were done the next day. No issues were found!
- Mattew Kennedy of Chadwick-BaRoss was onsite Aug 29 for additional Enviro-Sight pole camera training, as Tom Molinari of the HDS and W&C new hires Ben P. & Clyde L. will all be using this camera for collection system work.
- The newly rebuilt motor for influent pump #2 was installed on Aug 29 and subsequently wired back in by contractor Hi-Voltage Electric the next day.
