BY MAIL or DROP OFF

Complete the application form below, verifying owner information, street address, and pet description(s). Enclose the form in an envelope, including rabies certificate and a check or money order for the total payable to **Town of Hull**. Do not send cash. Mail to the Town Clerk or drop off in person at the Clerk's office located at Hull Town Hall, 253 Atlantic Ave.

IN PERSON

Come to the Office of the Town Clerk during office hours. Please bring rabies certificate and the completed application with you.

ON-LINE

Purchase or renew licenses online at www.doglicenses.us/MA/Hull. Credit card payments only. Per license convenience fee applies. Rabies certificates are required and may be attached to the order during check-out, mailed, faxed, or emailed to townclerk@town.hull.ma.us.

All dogs six months or older located within the Town of Hull must be licensed. Licenses are renewable annually and are valid January 1 thru December 31. **No license is issued for a dog not having a current rabies vaccination.** To have your license(s) mailed to you, please include \$1.00 for postage and handling, or you may pick up at the Town Clerk's office. The license fee is waived for service animals as defined by the Americans with Disabilities Act and for those residents 70 years of age or older. Owners must apply by mail or in-person at the Town Clerk's office and provide proof of status and current year rabies certificate. Purchased licenses are non-refundable and non-transferable. Tags must be worn by dogs at all times. If your dog should become lost, please contact the Town Animal Control Officer.
